

Goals of the Focus on Kids Program

As a result of attending the program, parents will:

- Understand the importance of sustained, supportive, and nurturing involvement by both parents.
- Obtain information on children's developmental needs, abilities, and common reactions to divorce.
- Learn about specific behaviors that are helpful in a co-parenting situation and behaviors that should be avoided.
- Receive additional information on community resources.

Children will cope better if they feel loved and supported by both of their parents during and after the divorce.

Focus on Kids satisfies the Missouri law that requires parents who are divorcing to attend an educational parenting program. It is conducted in cooperation with Missouri's circuit courts.

- Parents of the same child **MUST** attend separate sessions.
- Childcare is not provided, so children are not allowed to attend.
- Pre-registration and pre-payment required one week before the session.
- If you need to reschedule, please do so by 24 hours before the day you are scheduled to attend. Fees will be forfeited if you do not reschedule or attend. (No refunds unless the session is cancelled.)
- Sign-in and sign-out is required. Plan to arrive 10 minutes early and to stay for the entire two and one-half hour session.
- Participants receive a certificate of attendance when they attend the entire session. The certificate is presented to show completion of the Focus on Kids class at court.
