## **Sale Manager's Statement**

This is the 45th ALL-BREED TESTED BULL SALE held in Palmyra and sponsored by the Northeast Missouri Beef Cattle Improvement Association. It is a cooperative effort between breeders and the University of Missouri Extension Livestock Specialist.

The bulls offered have met certain predetermined standards in order to be eligible for this sale. All the offering has been in the Missouri On-Farm Testing Program and under the supervision of the University of Missouri Extension Livestock Specialist or have been fed in a supervised official test station, or their respective Breed Association Program.

The most important standards these bulls have met are EPD requirements; yearling height 49 in.; weight at a year, 1100 lbs or above; semen tested and examined for breeding soundness and found to be satisfactory potential breeders. To explain how adjusted weights are determined, study the following formula closely. The 365-day weight and 205-day weight will be calculated with the use of an age of dam adjustment factor.

$\frac{\text{Wt. at 320-440 days minus actual weaning weight}}{\text{No. of days from weaning to final weight}} = \text{Average Daily Gain}$

$\text{ADG} \times 160 \text{ days} + \text{adj. 205-day Wt.} = \text{Adj. 365-day weight}$

For figuring 205 adj. wt.

$\frac{\text{Actual Weaning Wt. minus Birth Wt.}}{\text{No. of days of age}} = \text{Preweaning ADG}$

$\text{ADG} \times 205 \text{ days} + \text{birth wt.} + \text{Age of dam adjustment} = \text{Adj. 205 day wt.}$

Age of dam adjustment factor used is from the recommendation of the individual breed Associations.

The bulls selling will be in breeding condition. They will have been tested for Brucellosis and vaccinated for Lepto and had a semen test within 60 days of the sale. They are also tested and negative for BVD PI. Non-Virgin bulls and bulls over 24 months of age are tested and negative for trichomoniasis.

### **SALE ORDER:**

Any A-minus bull or bulls, regardless of breed, will be sold at the beginning of the sale.

The remaining bulls will be sold according to sale index. The sale index is based on the following factors - Adjusted 365-day weight = 20%; adjusted 18-month height = 20%; sale day Grade = 20%, yearling weight EPD=20% & calving ease EPD=20%.

## **Required Performance & Conformation Information**

- A. The bulls must be produced in a Registered herd that is enrolled in the Missouri On-Farm Performance Testing Program, or their respective Breed Association Program.
- B. The bulls eligible for the 2017 spring sale must have been calved from January 1, 2015, through February 28, 2016.
- C. All calves in the herd eligible for registry must have been weighed at weaning for that season. Herd definition - All cattle on a given farm and handled as a separate unit.
- D. The bull calves nominated must be weighed at weaning between 120 and 250 days of age.
- E. The bull's yearling weight must be taken between 320 and 440 days of age. He must have adjusted 365-day weight of 1100 pounds or above, grade a B-minus or above and measure 49 inches or above at the hip. Yearling hip height in inches converted to Frame Score are: 45-46.9 in. = 3 frame; 47 to 48.9 in. = 4 frame; 49-50.9 in. = 5 frame; 51-52.9 in. = 6 frame, and 53 to 54.9 in. = a 7 frame.
- F. All bulls must be in the upper 50th percentile for EPD in two out of four traits: CE or BW, WW, YW, Milk.
- G. Yearling weights must be supervised by the Extension Livestock Specialist.
- H. If the bull has been used or in service prior to the sale it will be announced from the auction block.
- I. Bulls to be eligible for this sale will have to be owned as a cow-calf unit prior to the time the calf is 120 days old. Exceptions to this rule in partnership cattle, leased herds, etc. will be determined by the sale committee prior to consignment.
- J. All bulls must be semen tested and examined for breeding soundness by a veterinarian within 60 days of sale, using standard assay analysis of semen approved by the School of Veterinary Medicine, University of Missouri. Bulls with soundness defects will not be sold.
- K. All bulls must be at the sale location by 7:00 a.m. the day of sale.
- L. All bulls will be weighed, graded for conformation, feet and leg scores, measured for height sale day beginning at 7:00 a.m.

## **Terms and Conditions**

TIME: Sale will begin at 1:00 p.m. Saturday, March 25, 2017.

BIDDING: Each animal on which there are two or more bids will be sold to the highest bidder.

TERMS: The terms of the sale are cash. Bring your personal or local bank check.

DISPUTES: The auctioneer will settle any and all disputes as to bids by declaring all bids off and reselling the animal in question.

HANDLING: Each animal will be purchaser's risk as soon as sold, but will be cared for by the owner for a reasonable period until they are loaded, free of charge to the purchaser, but at his risk of loss or injury. All bulls are sold and will be paid for prior to loading.

CERTIFICATES: A certificate of registry and transfer will be furnished for each animal sold by respective breeder.

BREEDING GUARANTEED: All animals of breeding age (15 mos. or older) at the time of sale are guaranteed breeders. Bulls are guaranteed breeders if properly cared for and not used with the herd until 15 months of age. Any bull which settles at least one-third of the healthy cows he breeds will be considered a breeder. Any animal that has not proven itself a breeder within six months after the sale date, if in healthy condition, and meets the health regulations of the State of Missouri, may be returned to the farm of the seller, at buyer's expense. The seller reserves the privilege of trying, for a period of six months, to prove the animal a breeder. If proven a breeder, the animal will be returned at buyer's expense. Should an animal fail to prove a breeder in the specified time period, the seller will refund the full purchase price which shall be considered as full settlement and satisfaction of all claims. All complaints regarding breeding difficulties must be reported in writing by the buyer to the seller within six months.

ANNOUNCEMENTS: Announcements from the auction block will take precedence over the printed matter in this catalog.

CONTRACT: The above terms and guarantee shall constitute a contract between the buyer and the seller of each animal sold.

SALE ORDER: Bulls will be sold by index.

HEALTH: The bulls have been tested for Bang's and vaccinated for Lepto disease within 60 days of sale date. Health certificates acceptable in any state will be furnished. Bulls have also been tested negative for BVD PI, and Non-Virgin bulls & bulls 24 months of age and older are tested and negative for trichomoniasis.

LIABILITY: All persons attending this sale do so at their own risk, neither the sale committee, the Northeast Missouri Beef Cattle Improvement Association nor the sale manager or the market facility assume any liability, legal or otherwise.



## SHOW-ME SELECT REPLACEMENT HEIFER PROGRAM

The Show-Me Select Replacement Heifer Program was started in Missouri in 1997. The first year approximately 1500 head of heifers were enrolled in the program with 520 head selling in two sales for a gross value of \$410,000.

The program is designed to produce bred replacement heifers that are reproductively sound, bred to easy calving bulls and healthy. The purpose is to try to increase the chance of the heifer having a live, healthy, good quality calf, as well as extend the life of the heifer in the owner's herd.

In 2016, the Northeast Sale held at Palmyra sold 240 head for an average of \$2,054.00.

Requirements for the program and more information is available through your University Extension Livestock Specialist.

One of the requirements for the program is that the heifers must be bred to bulls with strict birth weight calving ease EPD's. Some examples of these requirements follow:

## EXPLANATION OF EPD's

**Expected progeny differences (EPD's)** - provide the best means of comparing genetic merit of animals within the breed. For each trait evaluated, the EPD incorporates the animal's individual and progeny performance with sire evaluation information, the evaluation also utilizes information from related traits and accounts, in part, for differences in the genetic merit of herdmates as well as genetic trends within the breed. Each trait evaluation predicts expected progeny performance relative to a fixed breed average - hence the term "Expected Progeny Difference." The key word is "difference." The EPD itself does not imply "good" or "bad" performance, only whether the performance of progeny is expected to be above or below that of progeny from average parents. Breeders should, on an individual basis, decide what is best for them by considering what traits are important to their program, their current herd performance, and the degree of change desired.

**Accuracy (ACC)** - A measure of certainty regarding the EPD evaluation for a performance trait. Accuracy is reported as a decimal number between zero and one; larger values indicate greater accuracy and more certainty that the EPD will not change as additional progeny information is obtained. Accuracy values of less than .20 are typical for individuals with few progeny.

**Birth Weight EPD** - The expected difference in average birth weight (lbs.) of progeny. Positive values indicated heavier-than-average birth weights. Birth weight reflects prenatal growth potential and may also be used as an indicator of calving ease.

**Maternal Milk EPD** - The expected difference in average weaning weight (lbs.) of daughter's calves which is attributed to milking ability. This evaluation is obtained by subtracting 1/2 of the Weaning Weight EPD (the direct effect on growth) from the Maternal Weaning Weight EPD. Positive values indicate above-average milking ability of daughters.

**Calving Ease EPD** - Predicts the average difference in ease with which a sire's calves will be born when bred to first calf heifers compared to calves from another sire. It is expressed as a percentage of unassisted births with a higher figure being better.

**Weaning Weight EPD** - The expected difference in average weaning weight of calves. The evaluation reflects the genetic influence on pre-weaning growth rate. Positive values indicate heavier-than-average weaning weights.

**Yearling Weight EPD** - The expected difference in average yearling weight of progeny. The evaluation reflects genetic influence on both preweaning and postweaning growth rate. Positive values indicate heavier-than-average yearling weights.

## SOUNDNESS SCORE

Hoof and soundness scoring is not an exact science, but in order to place a subjective score on these bulls for your consideration, a committee evaluates them at the sale considering hooves, joint angularity and movement. A scale of 1 to 10 is used, with 1 being essentially unsound and 10 perfect. Keep in mind that perfection is seldom attained. Conditions that may be encountered and the relative scoring is given below.

---

10 or 9 Perfect or near-perfect in hoof size, toe shape, joint angles and movement. No Blemishes.

---

8, 7 or 6 Bulls would be considered basically sound. Good foot size, even toes, good heel depth, correct slope to pasterns, legs and shoulders.

---

5 or 4 Bulls in this range have acceptable soundness with no serious problems. Would include mild toe unevenness, slight rolling of toes, moderate heel depth, some possible toe growth and only slightly excessive angle or straightness to shoulder, hock, and pasterns.

---

3, 2 or 1 One or more serious faults that impair their movement and expected longevity. Includes excessive toe growth, spread toes, hooves that roll under, corns, uneven toes, cracked hooves, too little or too much angle to shoulder, hock and/or pastern resulting in short or long strides. Possible swollen joints.
