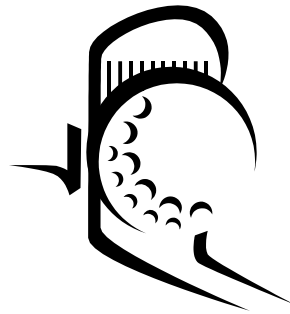

2 Person Scramble

The 2019 rules of golf shall be observed except for the following local rules:

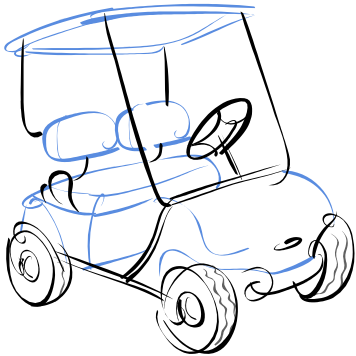
I. Preferred Lies:

- A. Two club lengths not nearer hole or nearest point of relief not nearer hole creating similar lie outside rock areas.
- B. Rule is not in effect if ball is behind trees or if swing or ball flight is restricted by trees.
- C. Hand place ball without creating an improved lie.

2. Playing from Hazards

- A. First ball shall be played as it lies, second ball shall be hand placed creating as similar a lie as possible.
- B. All putts shall be holed out and the first ball holed shall count.
- C. All ties will be settled on the Payne System.
