## PART 5: CELL PHONE AND DRESS CODE POLICIES

### Cell phone policy:

We have a “no-cell phone” or “electronic device” policy at camp. Aside from the fact that we have limited service at the campground, cell phones, iPads, iPods, and other electronic devices are expensive and can get lost or stolen. The physical camp environment is not kind to such items, but aside from that, we want your child to be fully engaged in camp activities. In addition, when children come to camp they—and you—are making a leap of faith, temporarily transferring their primary care from you as their parents to us and their counselors. This is one of the growth-producing, yet challenging aspects of camp. As children learn to trust other caring adults, they grow and learn, little by little, to solve some of their own challenges. We believe this emerging independence is one of the greatest benefits of camp. It is one important way your child develops greater resilience.

We agree to tell you if your child is experiencing a challenge in their adjustment to camp. *You can help* by talking with your child *before they leave for camp* and telling them there is always someone they can reach out to, whether it be their counselor, a trusted activity leader, a staff member or camp nurse. We are all here to help.

If your camper is found with a cell phone, iPad, iPod or other similar device, the child will call you on a staff cell phone to explain that we have their device and if you need to reach them, you may call a staff member.

### Dress Code:

During your stay at 4-H Camp, we want you to have the best experience possible. Campers, volunteers and staff need to remember we are representing Missouri 4-H and should dress accordingly. The following dress code has been adopted for everyone attending camp.

- Clothing shall be neat, clean and worn within the bounds of decency and good taste as appropriate for 4-H events. Skintight clothing and visible undergarments are not permitted.
- Articles of clothing displaying profanity, products or slogans promoting vulgar, obscene, inappropriate or offensive messages or images will not be allowed.
- Shorts, skirts, or dresses need to be at a modest length.
- Items of clothing which expose midriff, navel, bare back, or cleavage, open sided shirts (exposing the side or undergarments of the individual), one-shouldered shirts, shirts that are transparent/ see through are not allowed. Shirt hems should be at least two inches below the waistline.
- All tops/shirts should have straps wider than one inch. Camisoles are permitted, if worn under another shirt. Spaghetti straps, halter-tops, strapless and tube tops are prohibited.
- Swimsuits for males-Appropriate swim trunks only. (No shorts, cut-off jeans or Speedos. This is a Trenton Pool rule)
- Swimsuits for females– A one piece swimsuit or modestly cut two-piece. If two-piece, a t-shirt must be worn over it.
- Closed toed shoes must be worn at all times, except during swimming or showering when flop-flops/sandals are allowed. Pack comfortable shoes, since there will be a lot of walking during the day.
- Hats and caps may be brought to camp, but should only be worn when appropriate. No hats are to be worn during meal times.

Camp counselors, chaperones, and staff will insure that the dress code is followed. Campers may be asked to change if clothing is deemed inappropriate or questionable in terms of modesty.
