# Horse Show—Saturday, June 19

The Horse Show is the pinnacle of the 4-H horse project and offers opportunities to 4-H youth to compete and showcase the skills they have learned. *Registration due by June 18, 2021.* 

# Livestock Show—Saturday, June 26

The Livestock Show is the pinnacle of the 4-H beef, swine, sheep, goat, rabbit, and poultry projects and offers opportunities to 4-H youth to compete and showcase the skills they have learned. *Registration due by June 12, 2021.* 

## 4-H Exhibit Conference Judging – Friday, July 16

In conference judging, a 4-H member sits down with a judge at the fair and talks with them about their 4-H project exhibit. Judges will award ribbons and placings according to the exhibitor's knowledge about the exhibit and the quality of the exhibit. Exhibits will then be placed on display for others to view. **Registration due by July 2, 2021.** 

## Skillathons — Fri-Sat, July 16-17

A skillathon is an event that uses the experiential learning model of doing, reflecting, and applying to test one's knowledge. The word "skillathon" is derived from the suffix -athon, which means an event, and the prefix skill, or what is being tested at the event. Skillathons will be set up at different stations for members to participate on their own time, each taking about five minutes to complete. **No registration required, open to all.** 

## Exhibit Viewing—Saturday, July 17

After conference judging on Friday, exhibits will be placed on display in the gymnasium for others to view. 4-H members and families will have the opportunity to walk through the building to view 4-H exhibit projects on display anytime between 9am-12pm. *No registration required, open to all.* 

## Dog & Small Animal Show — Saturday, July 17

The dog and small animal show is the pinnacle of the 4-H cat, dog, pet projects and offers the opportunity to 4-H youth to compete and showcase the skills they have learned. *Registration due by July 2, 2021.*

The 4-H project leader or FFA instructor is responsible for certifying that membership, age, and management requirements are met. Each exhibitor MUST have and BRING a copy of your current horse enrollment form WITH you to the show or sent in with entry form





# **4-H EXHIBIT & CONFERENCE JUDGING GUIDELINES**

All exhibits should reflect the educational learning gained from project work. Check Project List for project specific guidelines.



Jackson County 4-H and the Missouri 4-H Center for Youth Development is under the direction of University of Missouri Extension.

"Learning By Doing" is the basis of 4-H work, and each year thousands of young Missourians between the ages of 5 and 18 do just that. 4-H members make the items displayed in at the Jackson County 4-H Fair. The Jackson County 4-H Fair provides a showcase for the skills and knowledge that members have gained through their 4-H experiences.

Besides developing practical skills and knowledge, 4-H members are developing "life skills". Under the leadership of adult volunteers, 4-H members learn to make sound decisions, work cooperatively in groups and develop a sense of self -worth and accomplishment. Missouri 4-H also fosters leadership, as older youth share their talents with younger 4-H members. We salute all Missouri 4-H members, volunteers and families, and particularly those whose "learning by doing" experiences are represented at the 2021 Jackson County 4-H Fair.

#### **4-H EXHIBIT GUIDELINES**

1. Items made by 4-H members should reflect the skills they have learned in their 4-H project, the needs and interests of the 4-H'er, and quality workmanship. Use the 4-H project literature, "Clover", and suggestions listed in this guide for ideas. Any 4-H member of an organized club in a defined delivery mode and who is enrolled in an individual project may exhibit at the county level.

2. 4-H members may exhibit only in projects in which they are enrolled in the current 4-H year. 4-H members can display items must be made in the current year and must be the work of the 4-H member submitting the item. If not enrolled, 4-H members may exhibit in open class—these projects will not be eligible for premiums or State Fair.

3. Items are displayed at the risk of the 4-H member. The 4-H staff, Fair Committee, and 4-H Council are not responsible for loss or damage to items. 4-H staff and volunteers do make ongoing efforts to protect all projects while they are physically on display, including strategies to keep fairgoers from touching items (e.g. chain barriers and "DO NOT TOUCH THE PROJECTS" announcements).

4. A member is limited to four items per project area and unlimited demonstration. Additional items beyond the four may be exhibited in open class. Clover Kids are eligible to bring 6 items, which will ONLY be displayed in the Clover Kids area, NOT in other project areas.

5. The 4-H member's region, county and name should be permanently affixed to the following items. These items will be accepted from any project. Youth who show notebooks and scrapbooks should understand their items may be handled at the fair.

\*Notebook – 3-ring binders are preferred.

\*Posters – no larger than 14" X 22", flat only, 3D items shall not be more than 1/8" above the surface of the poster board.

6. All exhibits should reflect the educational learning gained from project work.

This includes notebook pages, file cards, photo displays, posters, or educational displays. Be sure to mark the exhibit tag with Project number and description. Size restrictions may apply. See additional information in Rule #7.

7. Because of display space, available cases and number of exhibits in certain projects, dimension criteria is specified. Items which do not comply with size or other specifications will not be displayed or receive a ribbon. There should be no posters, or patterns attached to projects.

Educational display - Educational displays should not exceed 12 inches in height, 12 inches in depth, and 12 inches in width. Can include threedimensional items and must be free standing. (Posters with items taped to them do not qualify as educational displays. Science fair display boards are too large.)

Working models - These exhibits should show how things actually work (cutaway-sections of motors or other mechanical items) or can be used to help people identify parts, such as those of a motor or engine. Working models should require floor space no larger than 24" x 24".

8. All exhibit items must be checked in and out of the 4-H Fair by County Fair 4-H staff/volunteers during established times. (**No exceptions will be made.**) **No early removal or checkout of items is permitted unless prior approval is given by the building superintendents**. Items which are not properly checked in or out of the 4-H Building will not be awarded ribbons and/or premiums. Exhibits that are not picked up after the Fair, will be transported to the Jackson County 4-H Storage. All care will be taken with the item, however, we cannot guarantee that items will not be damaged, or possibly lost, if they are not picked up.

9. All items must have a Jackson County Fair exhibit tag securely fastened in a place visible to fairgoers. Two identification labels should be securely attached, sewn or safety pinned to each item, 1 on the outside/front of the item and a second one behind, underneath or inside (e.g., textile items such as clothing or knitted items). Multiple piece exhibits should be fully labeled and connected (Examples: jacket and skirt; rocket and rocket launcher). Each item in a multi-piece exhibit should be fully labeled and numbered to prevent items from being separated. Example: Each item in a 3 piece exhibit would be labeled with a State Fair tag and the notation, 1 of 3, 2 of 3, 3 of 3.

10. Jackson County 4-H Activity Fee—If a member paid the \$40 activity fee or sold fair sponsorship packages, no entry fee is needed. Otherwise, an entry fee of \$40 per member should be submitted with entry form or at check-in. Financial scholarships are available, contact 4-H staff for more information.

11. Online Pre-entry is due July 2 by 5PM. Online entry form can be found on the Jackson County 4-H website, or at <a href="https://missouri.gualtrics.com/ife/form/SV a5b0Ywi01kGdRpb">https://missouri.gualtrics.com/ife/form/SV a5b0Ywi01kGdRpb</a>

12. Fair T-shirts will be available for pre-order in the online fair entry form. T-shirts are for sale for \$8 apiece.

**13. Ribbons** - Judges will determine which exhibits receive blue, red, and white awards, using the Danish system of awarding ribbons. The Danish system is a method of evaluation where a product or process is evaluated against a set of standards, and recognition is awarded on the degree to which the standard has been met by each competitor. In Danish system judging, the exhibitors are not judged against each other.

 Blue = excellent exhibit; meets standards and expectations of the project. The exhibit shows high-quality work and needs little or no improvements.

•Red = good exhibit; meets most standards and expectations of the project. The exhibit shows high quality work; however, some improvements can be made in workmanship, design or expression of what was learned in the project.

•White = exhibit meets few standards and expectations of the project. The exhibit can be improved in workmanship, design or knowledge shared about the project.

In addition to the Danish system, the following ribbons will also be awarded.

•Dark & Light Purple = outstanding exhibits deemed "best in show" or best in project area, purple ribbons can only accompany a blue ribbon exhibit. Dark purple = champion or 1st place, light purple = reserve champion or 2nd place.

•Yellow = MO State Fair eligible exhibit and can be displayed in the 4-H Building at the MO State Fair in Sedalia, MO. Yellow ribbons can only accompany a blue ribbon. Judges will be select state fair exhibits and potential runners-ups.

All exhibitors will have the opportunity to pick up their ribbons on Saturday. Clover Kids will receive a clover kid ribbon for each exhibit along with one rosette per member.

**15. Conference Judging Awards** – Rosettes will be presented for High Point Awards at the Awards Ceremony. All exhibits in each project area will be counted toward high point for that project. High point selection will be made on the following point basis. Duplicate awards will be awarded in the case of a tie.

•Purple ribbon = 7 points

Blue ribbon = 5 points
Red ribbon = 3 points

•White ribbon = 1 point

16. Premiums for ribbons received are as follows:

•Clover Kids: \$0.50 •White ribbon: \$0.25 •Red ribbon: \$0.50 •Blue ribbon: \$0.75 •Purple ribbon: \$1.00 •State ribbon: \$1.25

**17. Protest procedure:** If a 4-H member or parent has a concern or issue during the Fair, a protest MUST be submitted in writing, signed by the 4-H member, and submitted to a 4-H Youth Specialist. Written protests must include:

•Names of persons involved.

Nature of concerns.

•Situation and documentation.

•Specific action, rule, etc. in question.

A committee will review the request; The 2 Fair Co-Chairs, 4-H Youth Specialist, Fair Committee member (youth or adult), and a 4-H member at large. The committee may discuss the situation with affected persons and officials prior to making a final decision. The committee will communicate appropriate action to the individual/group involved, both verbally and in writing.

#### PHOTOGRAPHY

#### **REQUIREMENTS:**

1. Photos must be mounted on a rectangular 8"x10" solid mounting surface.

2. The preferred surface is matte board. It can be the color of the photographer's choice.

3. The photographs mounted on each 8"x10" matte board must be 8"x10" or smaller.

4. The mounted photo should be placed in a clear plastic 8 % x 10 % inch sleeve.

#### PLEASE NOTE:

Solid requires that there are no cutouts (or other holes) in the matte board, either around or behind the photo (for example, a surface shaped like a picture frame is not a solid mounting surface). Sleeves are intended to protect these special exhibits from handling, dust and humidity

#### DIGITAL EDITING RULES

For State Fair 4-H photography exhibits, certain types of editing are permissible and others are not.

1) 1. Altering (editing to change the contents of) a photo is not permitted for State Fair exhibits.

• Examples include adding a sunset or object, removing someone from the shot, airbrushing to cover a bad complexion, giving a photo subject dinosaur eyes, etc.

2) Enhancing (editing to improve the existing qualities of) a photo is permitted.

• Examples include cropping the photo, eliminating redeye and changing levels of saturation, brightness, contrast, etc.

\*Include name, address and county on the back of each photo.

#### CAKE DECORATING

Decorated Cakes - Cakes should not exceed 13" in height or at the base. Cake boards should not exceed 1" margin on each side of cake form and is considered in the 13" base requirements. Cake boards should be sturdy, especially if using a cake pan. The use of Styrofoam forms is recommended.

May only use Royal Icing, Rolled Fondant or commercial product that will harden and preserve the decorated cake. Cakes may only contain non-perishable items. They should not be real cakes, use butter crème icing or tube/gel icing, or include items such as pineapple tops or real flowers. Adding Tylose powder to fondant will help it hold its shape in humidity.

Cakes with candy decorations are allowed; however, avoid using candy that melts (e.g., M & Ms, candy canes, etc.). Cakes that have melting items will be removed from display. No more than six (6) per county total - all levels.

#### FOODS/NUTRITION/PRESERVATION

2. Submit food items on disposable, clear, plastic plates. Plastic wrap will be removed so drying of the food will extend display life of the product. Food items will be displayed with their tags. Please do not send expensive or keep-sake containers!

4. Perishable food items will need a second identification label. Perishable food items will be displayed with their tags.

5. Biscuits, cookies, muffins and other small items should be four per plate. Non/Undecorated cakes should be displayed in mini-versions (portions of 1/3 to 1/4 of a larger total product.)



# **4-H FAIR DEMONSTRATIONS & CONTESTS LIST**



All demonstrations should reflect the educational learning gained from project work.

Online Pre-entry is due July 2 by 5PM. Online entry form can be found on the Jackson County 4-H website, or at <a href="https://missouri.gualtrics.com/ife/form/SV\_a5b0Ywi01kGdRpb">https://missouri.gualtrics.com/ife/form/SV\_a5b0Ywi01kGdRpb</a> Fair T-shirts will be available for pre-order in the online fair entry form. T-shirts are for sale for \$8 apiece.

#### DEMONSTRATIONS

1. Team Demonstrations may consist of no more than three (3) members. An exception is made for skits presented in Theatre Arts project. Theatre Arts may consist of no more than seven (7) members. Please refer to specialty contests which may have stricter rules.

Demonstrations involving firearms, live animals, open flames or other unusual circumstances must call Jessie Furgins at 816-252-5051 in the Jackson County
 4-H Office for pre-approval.

3. Demonstrators must provide their own ingredients, equipment, extension cords and props. A three-prong electric outlet, demonstration table and easel will be provided by the Jackson County 4-H staff.

#### 4-H General Demonstrations

Judging Criteria: Not applicable

Age: Any age 4-H member

Length of time: 5-10 minutes

Project enrollment: May be enrolled in any 4-H project.

Other: General demonstrations are those where the 4-H member shows and tells others how to do something. They are more formal than working demonstrations; therefore, require the use of a microphone.

#### Working Demonstrations

Judging Criteria: Not applicable

Age: Any age 4-H member

Length of time: Approximately 30 minutes

Project enrollment: May be enrolled in any 4-H project.

Other: Working demonstrations are more casual than General Demonstrations. Working demonstrators do not use a microphone or stage. Youth work on a project while responding to fairgoers questions. A poster giving the topic of the demonstration and the 4-H member's name can be displayed on the table during the working demonstration.

#### **Clover Kid General or Working Demonstration**

Clover kids are invited to participate in the demonstration contest, either with a general or a working demonstration. Please refer to the guidelines for these demonstrations for specific information. However, Clover Kids do not need to follow the same time limits, and can have demonstrations that are shorter in length.

#### SPECIALTY CONTESTS

#### Pork Contest

Judging Criteria: Demonstration may be on any facet of pork, including food, nutrition, production practices, or by-products. Demonstration topics should be

challenging and exhibit contestant's knowledge as well as presentation skills.

Age: Any age 4-H member (8-10, 11-13, 14 and older)

Length of time: 20 minutes, including preparation, demonstration and clean up.

Project enrollment: Members must be enrolled in Foods/Nutrition or Swine projects.

Sample required: A sample of the food and a copy of the recipe should be given to judges.

Team: Teams of two are allowed only in the 8-10 year division.

Other: Animals may not be used.

#### International Topic Demonstrations

Judging Criteria: The best demonstration will include a lot of information about the place where the item originates and the people who use the item.

Age: Any age 4-H member

Length of time: 7-10 minutes

Project enrollment: May be enrolled in any 4-H project.

Sample required: If the item made is a food item, a copy of the recipe, nutrition information and a sample of the food should be given to judges.

Team: Team demonstrations are allowed.

#### Egg Contest

Judging Criteria: Each contestant prepares an egg dish and also presents information that reflects the contestant's knowledge about eggs, including: nutritional value, preparation, storage, function, grading-sizing, versatility and economics of cooking with eggs.

Age: 8-13; 14 and older

Length of time: No more than 12 minutes

Project enrollment: May be enrolled in any 4-H project.

Sample required: Present a finished product for judges' sampling and a recipe handout for the judges.

Team demonstrations: Not applicable.

Other: 1. Recipe must contain 1 whole egg per serving if a salad or main dish, ½ egg per serving if an appetizer, snack, dessert or beverage.

#### Chicken Bar-B-Q Contest

Judging Criteria: Contestant's barbecue skills as demonstrated while preparing/ cooking the chicken, and by judges' sensory evaluation of the finished product.

Age: Age 14-18 as of January 1st of current program year.

Length of time: 2 1/2 hours time limit. Cooked product must be turned in by 12 Noon.

Project enrollment: May be enrolled in any 4-H project.

Sample required: Three (3) barbecued chicken thighs should be presented to the judges on provided plates or containers without garnishes.

#### Other:

1. Contestants may have one adult (leader or parent) as a coach supervising and assisting during set-up, although cooking and product handling is restricted to the contestant. Electricity or portable generators may not be used or provided.

2. Contestants must furnish all equipment, food, and supplies, including sauce (commercial or private recipe). A small work table may also be useful.

3. Contestants may use their own grills if it does not exceed 350-400 square inches. Baskets may not be used for turning. Small containers may be used on the grill only for heating sauces although foil may be used to wrap or shield the thighs while cooling.

4. Thighs may be prepared boneless or bone-in.

5. The contestant may not puncture the thighs to inject fluid or sauce into the meat.

6. Contestants use charcoal barbecue grilling techniques and present three (3) barbecued chicken thighs to judges on plat or container, without garnishes, at or before the end of the 2.5 hour period. In addition, the youth should give the judges a standard recipe card with information about sauce (brand or major ingredients) and key cooking instructions.

#### **Cooking with Honey Contest**

Judging criteria: The demonstrator must use honey grown or made by a Missouri honey producer or company; provide the honey producer or company's name; give nutrition information; the health benefits of honey and the benefits of pollinators. The demonstrator must present a finished product for judges' sampling and a recipe handout for the judges.

Age: Any age 4-H member (8-10, 11-13, 14 and older)

Length of time: 20 minutes, including prep, demo and clean up

Project enrollment: Any project

Sample required: A sample of the food and a copy of the recipe should be given to judges.

The Missouri Beekeeper's web site http://mostatebeekeepers.org includes a list of regional beekeeper associations.

#### Missouri Grown Foods Contest

Judging Criteria: The demonstrator must use a food product grown or made by a Missouri producer or company; provide background information on the producer or company, nutrition and preparation information, and the economics of the food product and the final dish. The demonstrator must present a finished product for judges' sampling and a recipe handout for the judges.

Age: Any age 4-H member (8-10, 11-13, 14 and older)

Length of time: 7-10 minutes

Project enrollment: May be enrolled in any 4-H project.

Sample required: A copy of the recipe and sample of the food should be given to judges.

Team: No team demonstrations allowed

#### PUBLIC SPEAKING CONTESTS

Age divisions for the public speaking contest are: Junior (ages 8-10), Intermediate (ages 11-13) and Senior (ages 14-19). Members may present ONE speech. Rules for each category are on website at: https://extension.missouri.edu/ programs/missouri-4-h/4-h-projects-opportunities/4-h-opportunities/4-hpublic-speaking-contest

#### **Illustrated Talk**

The illustrated talk is informative. It is not a "how to" like a demonstration. It may be an individual or team talk by two members. It is to be illustrated by way of posters, pictures or other media (recordings, power points, video). Often members use actual articles for visual effect. Live animals may be used, but should be confined. There is no requirement for enrollment in related projects, but the member may want to use knowledge acquired in project work to share with the audience. Members should be prepared to answer questions. **Time Limit: 7-10 Minutes.** 

#### Prepared Speaking

This is the noble, "traditional" category from past Missouri State 4-H Public Speaking Contests. Speeches may be on any topic of the participant's choice that are in good taste for a group of peers and adults. Speeches should be 3-5 minutes for Juniors, 4-6 minutes for Intermediates and 5-7 minutes for Seniors. Points will be deducted for speeches not meeting these parameters. When speakers have met the minimum time, a judge will hold up a green card. When 30 seconds remain until time is expired, the judge will hold up a red card. The speaker should then wrap up to avoid a point deduction (3 points).

#### Extemporaneous Speaking

When you give an extemporaneous speech at a public speaking contest, it will differ from a traditional ("prepared") public speech in that you will not plan the speech until shortly before you deliver it. Extemporaneous speakers will wait together in a common room until their name is called. At that point the speaker will pick three topics and select one that they will speak on. Speeches will be given before the judges and the audience in a separate room. Each speaker will have 15 minutes to prepare their speech after the selection is made. Topics will be subjects that youth are familiar with, so no special research materials are required. Timing: Speeches are to be 3-5 minutes in length for Juniors (ages 8-10), 4-6 minutes in length for Intermediates (ages 11-13) and 5-7 minutes in length for Seniors (ages 14-18). When speakers have met the minimum time, a judge will hold up a green card. When 30 seconds remain until time is expired, the judge will hold up a red card. The speaker should then wrap up to avoid a point deduction (3 points). Notes on index cards are perfectly acceptable. Speakers should bring their own note cards and pencils. Topics must be appropriate to the standards of a 4-H event and appropriate for all ages. Restrictions: No props or visual aids may be used. Parents are not allowed to assist the speakers or to be in the same room as they prepare their speech.

#### Public Service Announcement

Create an audio or video about Missouri 4-H that could be played on the radio or on television. You'll introduce yourself and your video to the judges, play the video and then answer questions from the audience. Videos must be 60 seconds in length or shorter.

#### **Technology Assisted Speaking**

Technology assisted speeches are subject to the same rules and guidelines as prepared speeches but allow for the use of presentation software (such as PowerPoint). This is another 4-H experience with excellent workforce preparation benefits. Speeches are to be 3-5 minutes in length for Juniors (ages 8-10), 4 -6 minutes in length for Intermediates (ages 11-13) and 5-7 minutes in length for Seniors (ages 14-18). When speakers have met the minimum time, a judge will hold up a green card. When 30 seconds remain until time is expired, the judge will hold up a red card. The speaker should then wrap up to avoid a point deduction (3 points). The tech-assisted speech must be an original work, created and written by the person giving the speech. Topics must be appropriate to

the standards of a 4-H event and appropriate for all ages. Notes on index cards are perfectly acceptable. However, no props may be used. Speakers are free to use their own laptop computers, or they may use the PC laptop at the event. In either event, a copy of the presentation must be brought to the contest by the speaker, in order to have a backup if technical difficulties should occur.

#### Interpretation

Interpretations are memorized performances that take place without music or other external sound effects. You can choose from three of the following subcategories:

**Dramatic**—An oral interpretation of a serious selection of narrative or dramatic work. The source material may come from literature, a monologue, a theatrical production or poetry. This can be a great fit for youth in 4-H Theater Arts clubs!

**Humorous**—A memorized oral interpretation of a humorous selection (or a humorous interpretation of an oral selection. Source material may come from plays, prose, literature, poetry, or other performance pieces.

Interpretations are to be memorized and take place without music or other external audio or visual effects. Visual aids, such as posters, are not permitted, but special makeup and clothing may be worn as the contestant deems appropriate to the content of the interpretation. The topic and content of the interpretation must be appropriate to the standards of a 4-H event, and appropriate for all ages. \*\*PLEASE NOTE: There are painful moments of history that are important to remember (lest the past be repeated) and would normally provide excellent material for a dramatic interpretation. However, with an audience that includes very small children (who don't yet have a context for this information), depictions of things like beatings, torture, child deaths and genocide are not appropriate for the State 4-H Public Speaking Contest. Time limits: Due to contest time constraints, all interpretations are limited to 5 minutes each (with a minimum time of 3 minutes), for Juniors, Intermediates and Seniors. When speakers have met the minimum time, a judge will hold up a green card. When 30 seconds remain until time is expired, the judge will hold up a red card. The speaker should then wrap up to avoid a point deduction (3 points). Contestants are to bring two copies of the script, referencing the source(s). Non-English language must be translated. If speaking in a language other than English, the participant must inform the state 4-H office no later than September 1 of the program year, so that a judge with the appropriate language skills may be secured.

#### FOOD REVUE CONTEST

The Food Revue Contest integrates food and nutrition knowledge into one activity. Food preparation, menu planning, nutritional knowledge, table service and food handling practices will all be evaluated. Contest open to 4-H members enrolled in ANY foods project. 4-H members may only have one exhibit (one table). All tables must be set and ready to be judged by the start time. 4-H member must supply: 1. Their own card table, 2. Two place settings – complete with all silverware, plates, bowls, glasses, etc., 3. A complete menu (on 8  $\frac{1}{2}$ " x 11" poster board, integrating one of the contest themes), 4. <u>One</u> food item from their menu for the judge to taste and evaluate. Foods items must be prepared prior to contest. No refrigeration or cooking items available. 5. A recipe for the one prepared food item, on 8  $\frac{1}{2}$ " x 11" poster board. Age Divisions will be: Clover Kid – Ages: 5-7, Junior – Ages: 8-12, Senior – Ages 13-18. Themes for the Contest: Tailgate Party, Formal Dinner, Holiday.

#### **FASHION REVUE CONTEST**

All 4-H members enrolled in Clothing, Crocheting, or Knitting projects are encouraged to enter and participate in the Fashion Revue. For Fashion Revue Judging, contestants will model their garments. Each exhibitor will be limited to, at most, 3 items/outfits in the Fashion Revue Contest. Clover Kids are limited to one item/outfit. Each member in Fashion Revue will receive a PARTICI-PATION RIBBON. Top member in each class will be evaluated to select a top purple rosette ribbon. Individuals will be selected to represent Jackson County at the State Fashion Revue competition. Two 4-H members who are 14 years of age and up by January 1, of the current 4-H year. One from the Clothes you Make classes and One from the Clothes you Buy\*\* classes. Two 4-H members who are 11-13 as of January 1, of the current 4-H year. One from the Clothes you Make classes and One from the Clothes you Buy\*\* classes. Two 4-H members who are 8-10 as of January 1, of the current 4-H year, One from the Clothes you Make classes and One from the Clothes you Buy\*\* classes. \*\*In the Clothes You Buy category (Class FR4, FR5) the member must be enrolled in either Project 524 or 525. These classes are judged on quality and fashion coordination of outfits purchased. One 4-H member (8-18) from the Crochet and one from the Knitting class will represent Jackson County at the State Fashion Revue.

**SMALL ANIMAL & LIVESTOCK RULES & REGULATIONS** 



#### RULES

1. Members may show animal or products only in the projects in which they are Swi enrolled.

2. Members must show their own animals or if they are showing another animal in the same class, have another 4-H member show the animal for them.

3. All 4-H members enrolled in food animal projects including beef, sheep, swine, dairy cattle, meats, dairy goats, rabbits and poultry must complete the appropriate level of MSMQA certification to be considered a 4-H member in good standing in that project. In order to be eligible to exhibit your animal at the Jackson County Fair or State Fair you must complete the appropriate level of MSMQA. Missouri 4-H Food Quality Assurance Policies and MSMQA Information available at: http://agebb.missouri.edu/smga/

#### 4. Pre-Entry is required for all live animal exhibits.

5. All animal holding areas must be kept clean, and space over which visitors will pass in examining the animals must be free from rubbish. The superintendent of each department will enforce this rule. Exhibitors must furnish their own bedding. Each member is responsible for cleaning out their trailer area and removing all bedding and manure as directed.

6. Livestock Health Standards - Animals or poultry of any age or class showing evidence of disease will not be permitted to enter the fair grounds. Requirements for this show will be the same as those required at the State Fair. 7. All animals must be checked-in upon arrival.

8. Project Superintendents may, at own discretion dismiss exhibits due to inclement weather.

9. All animals must be on the grounds and checked in an hour prior to their show start time.

10. Missouri State Fair Rules & Regulations will be followed for livestock show

11. Members must show ownership of animal. Project leaders are responsible to make sure members are in ownership of animals by due dates listed.

12. Animals will have either tag, tattoo, or ear notches for IDs and no fresh or scabbed up ones will be excepted day of show.

13. Member is responsible to make sure animal is taken care of properly with adequate water and food available. Fans if needed to keep cool.

14. All market classes will be broke up by weight and breed. Breeding classes will be divided in to classes by DOB. All crossbreds will be divided accordingly.

15. Uncontrollable animals will be dismissed at Fair Committee's discretion.

16. Jackson County Fair Committee reserves the right and final discussion to make any needed changes to the rules or regulations when or if it is needed in best interest of the Show

17. Any member that violates any of the rules or regulations will forfeit any awards or money that is to be paid to them.

18. No Irritants, Sedatives or Stimulates may be used on or given to any animals. Suspected animals may be tested at Exhibitors expense.


