 - Farms: The SBA is still determining how forgiveness with work for farms. Documentation and accurate records/tax returns are key. To receive forgiveness for the 8-weeks of payroll, you will need to verify income through Schedule F.
 - o Farmer's markets are a little more straightforward, as a rule. The vendors are simply retailers.
