STUDY MANUALS

Certification exams are based upon the content of the study manuals. All applicants are required to pass the General Standards of Competence (CORE) Exam and the appropriate Category Exam. Questions for the CORE Exam will come from the National Pesticide Applicator Certification Manual (MU Extension Publication MX328) and the Missouri Pesticide Use Act. Questions for the Category Exam will come from the Category Manual, the CORE Manual and the Missouri Pesticide Use Act.

PESTICIDE EXAMS WILL NOT BE OFFERED AT THE CERTIFICATION PROGRAM

The CORE Manual and the Category Manual(s) may only be purchased from the University of Missouri Extension Publications Office. The Missouri Pesticide Use Act will be provided (free) to the applicant at the training program.

Manuals will be shipped directly to you within a few days of ordering. We advise you to order your manuals prior to training so you can use them as a reference during the classes.

REGISTRATION
