

## Method of retail sale for fresh fruits and vegetables

If you are selling fruits or vegetables direct to consumer through a farmers market, farm stand, or other means, it is important that you sell produce by the proper method, as indicated in the tables below.

<sup>\*</sup>Note that gallon bags are NOT considered a dry measure, so leafy greens cannot be sold by the gallon. They would need to be sold by a 4 quart dry measure container (or other dry measure, or by the head/bunch, or by weight). The product must be measured by an acceptable measurement and then could be transferred to a re-closeable plastic bag for transportation home.
